#### **ARTICLE 1**

#### NAME AND JURISDICTION

1.0 The name of this Corporation shall be the American Association for Nude Recreation - Western Canadian Region, Inc. and is composed of nudist clubs in the Provinces of British Columbia, Alberta, Saskatchewan and Manitoba, and such other territories and areas as may in future be agreed upon by all concerned.

#### **ARTICLE 2**

#### **AFFILIATION**

2.0 The American Association for Nude Recreation - Western Canadian Region, Inc. shall maintain a fraternal affiliation with the American Association for Nude Recreation and shall elect liaison representatives to that organization, such representatives to be called AANR Trustees.

#### **ARTICLE 3**

#### **PURPOSE**

- 3.0 The purposes of the American Association for Nude Recreation Western Canadian Region, Inc. are:
  - a. to foster and promote the practice of social nudism;
  - b. to assist in establishment of and improvement of nudist parks and resort for recreations and enjoyment of sports and entertainment for people who subscribe to the precepts and moral standards of this Association;
  - c. to publish, print, distribute and sell pamphlets, books, papers and other literature and organizational materials in the promotion of social nudism;
  - to do any and all of the forgoing and such other things as may be pertinent and related thereto:
  - e. to acquire, hold and dispose of real and personal property; to receive gifts and bequests in money or other form and to act as trustees of any funds or property that may be established for any specific purpose related to the attainment of full and complete expression of the purpose set forth herein; all of which said purposes and activities are subject to the existing laws of Canada and the several Provinces in which this Corporation shall be established;

f. to return any profits or other accretions to the Corporation for the further use in promoting its objects.

### ARTICLE 4 ADDRESS

4.0 The principal address shall be P. O. Box 1113, Station Main, Calgary, Alberta T2P 2K9 (subject to change if necessary).

### ARTICLE 5 DIRECTORS

5.0 The Board of Directors will consist of a minimum of 4 directors and a maximum of 10.

# ARTICLE 6 CLASSES OF MEMBERS

6.0 The Corporation is authorized to establish one or more classes of members as approved by the Members from time to time by Special Resolution. Each member shall be entitled to receive notice of, attend and vote (in accordance with the provisions of the Bylaws) at all meetings of the members of the Corporation.

# ARTICLE 7 DISSOLUTION

7.0 Prior to dissolution, the Corporation must: return property to another person if the property was originally given to the Corporation on the condition that it be returned when the Corporation is to be dissolved; and the Corporation must repay any debt or other liabilities of the Corporation. All remaining assets shall be distributed to member clubs on a pro rata basis according to the number of AANR members in each club. The share attributed to the Associates Members shall be paid to the American Association for Nude Recreation.
